All sealed bids clearly marked with the Project name and bid number must be placed in the Tender Box at the offices of the Kgatelopele Local Municipality, 222 Barker Street, Danielskuil, 8405, on or before 12:00 pm Wesneday,28 August 2019 at which time submissions will be opened in public. No emailed or faxed documents will be accepted. Tender box will be accessible from Monday to Sunday from 07h30am to 05hoo pm.

Bid documents submitted after 12:00 Wednesday, 28 August 2019 not be accepted.

Please note that it is a prerequisite of the Municipality that all service providers are to be registered on the National Treasury Central Supplier Database (CSD) and include in their bids, the tax clearance certificate or their Master Registration Number or tax compliance status PIN to enable the municipality to verify the bidder's tax compliance status. Registration on CSD can be done at www.csd.gov.za or at your nearest Treasury and Kgatelopele Municipal Offices.
