Background: In terms of section 46 of the MSA as amended reads as follows;

- (1) A municipality must prepare for each financial year a performance report reflecting–
 - (a) the performance of the municipality and of each external services provider during that financial year;*
 - (b) a comparison of the performances referred to in paragraph (a) with targets set for and performances in the previous financial year; and*
 - (c) measures taken to improve performance.**
- (2) An annual performance report must form part of the municipality's annual report in terms of Chapter 12 of the Municipal Finance Management Act.*
