The purpose of this process is to establish a database of suitably qualified local subcontractors that may be considered for subcontracting opportunities on municipal infrastructure and construction projects, subject to applicable legislation, municipal policies and procurement requirements.

Minimum Requirements

Interested contractors must submit certified copies (where applicable) of the following documentation:

1. Company Profile.
2. Valid CIDB Registration Certificate (Grade 1 or Grade 2).
3. Valid COIDA Letter of Good Standing.
4. Central Supplier Database (CSD) Registration Report.
5. Certified Identity Document copies of all Directors (not older than six months).
6. Proof of Business or Residential Address within the Kgatelopele Local Municipality area.
7. CIPC Company Registration Documents.
8. Valid Tax Compliance Status Pin or Tax Clearance Certificate issued by SARS.
9. Completion Certificates and/or Reference Letters for projects successfully completed within the last five (5) years.

Submission of Documents

Completed submissions must be placed in a sealed envelope clearly marked:
